

Privacy Policy – Slovak Design Award

The Announcer – Slovenské centrum dizajnu (SCD), Jakubovo nám. 12, P. O. Box 131, 814 99 Bratislava pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council (EU) 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter referred to as the “Regulation”) and Act No. 18/2018 on personal data protection (hereinafter referred to as the “Act”) acts as the controller.

Purpose of Personal Data Processing and Legal Basis

The controller processes personal data to perform the aim and subject of the competition stated in the “Competition Regulations” and “Terms and Conditions of the Competition”.

Such processing is necessary to perform the task carried out in the public interest or in the exercise of official authority vested in the controller (Article 6 (1)(e) of the Regulation in connection with Section 78 of the Act for the artistic purpose or literary purpose, and necessary to inform the public by mass media means.

We receive personal data directly from you or from third parties (e.g., from applicants).

We also process your personal data for the purpose of sending newsletters, but only upon receiving your consent for newsletter subscription by checking the relevant box (Article 6 (1) (a) of the Regulation).

Your Personal Data We Process

Standard personal data: personal data stated in the registration, i.e., your name, surname, whether you are a student, if applicable, competition category, your work, and other data relating to the competition, and the photographs you provided.

In the event that you are granted an award in the competition, your personal data will be published in compliance with Article XIII of the Terms and Conditions of the Competition on the identification of winners and the work.

Due to transparency and public interest, the competition organiser may decide to disclose the list of all registered works after the registration closes, and subsequently the list of works advancing from the 1st evaluation round.

In such case, your personal data will be disclosed in compliance with Article XIII of the Terms and Conditions of the Competition on the identification of winners and the work,

and the photographic documentation of the work attached to the application will be published.

SCD will ensure the publication and promotion of competition results – at the award ceremony, exhibition of awarded and selected works, in the Designum and e-designum magazines, at the SCD website and SCD social media, in print and electronic media, through short videos, at other events, such as seminars, conferences, and exhibitions at home and abroad.

If you attend the competition award ceremony, photographs will be taken and video recorded, which will be published on the SCD website, SCD social media, and in other media, if applicable.

For SCD newsletter subscription, personal data comprise: name, surname, and e-mail address.

Personal Data Storage Period

Your personal data is stored for the duration of the competition and for the subsequent 10 years after its completion for archiving purposes.

After the period will have elapsed, personal data will be liquidated (deleted), unless other legal reasons for their processing exist (exercising of legal claims, litigation, administrative proceedings, documents of lasting archival value, etc.).

For the purposes of SCD newsletter subscription, personal data is processed for 5 years.

Personal Data Protection Policy

We process your personal data only pursuant to legal obligations stipulated by the Regulation or Act.

Your personal data will be stored securely, in compliance with the security policy of the controller and processor, and only for a time necessary for performing the purpose of the processing.

Only persons authorised by the controller to process personal data will have access to your personal data, and they will process it based on instructions of the controller in compliance with the security policy of the controller.

Your personal data are not subject to automated decision-making, including profiling.

We do not transfer your personal data to third countries or international organisations.

RESPONSIBLE PERSON

Secure processing of personal data and compliance with the Regulation and Personal Data Protection Act is supervised by a responsible person, whom you may contact to exercise your rights.

YOUR RIGHTS PURSUANT TO THE REGULATION AND PERSONAL DATA PROTECTION ACT

Right of access

You have a right to receive a copy of the personal data which we have about you as well as information about how your personal data is used.

In most cases, your personal data will be provided to you in paper form, unless requested in a different manner.

If you requested the provision of such data via electronic means, such data will be provided electronically, if technically possible.

Right to rectification

We take appropriate precautions to ensure the accuracy, completeness, and currency of your personal data that we dispose of.

If you believe that the data that we have is inaccurate, incomplete or obsolete, do not hesitate to ask us to modify, update or amend such data.

Right to erasure

You have a right to request erasure of your personal data, e.g., in the event that we no longer need your personal data to perform the original purpose of processing.

However, it is necessary to assess your right in regard to all relevant situations.

For example, we may have certain legal and regulatory obligations and, therefore, will not be able to comply with your request.

Right to restrict the processing

In certain situations, you are entitled to request us to stop using your personal data.

These are, for example, situations that lead you to believe that your personal data at our disposal could be inaccurate, or if you believe that we no longer need to use your personal data.

Right to data portability

In certain situations, you have a right to request a transfer of personal data to a different third party of your choosing.

However, the right to portability relates only to personal data that we received from you based on consent or based on a contract, which you are a contractual party to.

Right to object

You have a right to object to personal data processing, which is based on our legitimate justified interests.

If we do not have a convincing legitimate reason to process and you file an objection, we will no longer continue to process your personal data.

Right to file a complaint

If you want to file a complaint regarding the manner in which your personal data is processed, including exercising the abovementioned rights, you can contact our responsible person.

All your requests and complaints will be duly reviewed.

Right to withdraw consent at any time

If you have granted us consent to process your personal data for a particular purpose, we are obliged to comply with the purpose and cannot change it during processing.

You can withdraw your consent at any time.

Withdrawing consent does not affect the legality of processing pursuant to consent before it is withdrawn.

You can deliver the withdrawal of consent via mail to the correspondence address or e-mail of the responsible person, or in a manner stated in the consent given, if applicable.

Should you feel unhappy about our response or believe that we process your personal data unjustly or illegally, you can file a complaint to the supervisory authority, i.e., Úrad
